# OUR YEAR

Scheduled Caste (SC) comprises more than 16 percent of population of India. Despite their large number and constitutional safeguards the SC continue to suffer from social and economic oppression. They have been excluded throughout the recorded history of India, stripped of their dignity and denied basic human rights by way of segregation and lack of access to developmental resources and the state of Bihar as well as district of Patna; Samastipur and Bodhgaya are no exception to it.

Past work experiences, primary and secondary data suggests that dalits and women in Developmental blocks of Tajpur, Morwa in Samastipur, Dobhi in Bodhgaya and Patna district are most deprived. Their control over resources, government Programs and policies is poor, participation in decision making process is negligible. There is total lack of awareness about the developmental programme of Government. The Government system at any level is not transparent.

The institutions like Health Sub Centre, School, ICDS Centre, are not providing quality basic services as envisaged. The arbitrary Governance is resulting into poor functioning of these institutions. This has resulted in the corruption in government programme and denial of civil rights of the socially excluded groups.

Rain fed agriculture is the main occupation of the people and the area is prone to drought. The Dalit community e.g., Musahar, Chamar, Dome, Washer man etc. who have been working for super class people of the Society but get nothing except few grains or money towards their livelihood. Their children also learn to follow up their ancestor since long back. The villagers of Mahadalit Community have no way out except to pay their services to earn for restoration of life. No land of their own, No educational support, No health security, no dignity to women.

DVAS intervention under the project was undertaken in Patna, Vaishali, Bodhgaya and Samastipur district with financial and technical support of IGSSS, OXFAM, CSD (TDH), NEG - Fire and CASA for 2019-2020 to empower the Dalit and Mahadalit community with focus on women on aspects as livelihood, access to rights and entitlements.

# STATE-LEVEL CONSULTATION ON OPPORTUNITIES FOR ENHANCING BASIC SERVICE FOR URBAN POOR

Within a generation, it has been estimated that the majority of the developing world's population will live in urban areas, and that the number of urban residents in developing countries will double, increasing by over 2 billion inhabitants (World Bank 2000). India is no exception. Some 50% of the population or around 600 million people may be resident in urban areas by 2020. These figures suggest that we need to know more about the process of urban development and its effect on urban residents, lives and as a development agency, we need to know more about the impact of urbanization generally on poverty reduction.

The state of Bihar too is growing very fast. It is currently at 104 million, which is an increase of over 25% from the 80 million recorded in the 2001 Census. Bihar's urban poverty ratio is 31.2 per cent in 2011-12, a reduction from the 2004-05 levels when it was 43.7 per cent (Bihar Economic Survey 2013-14).

Although urban centers present real opportunities for poor people, they also create and feed the conditions within which poverty spreads. On the positive side, economic growth, which is partially driven by urban development, increases the incomes of poor people. In addition, cities have the resources to improve the conditions within which people live and work, and they create the context within which poor people can demand and obtain redress from political and bureaucratic systems. Urban population increases are in part fuelled by rural urban migration as people seek new employment and livelihood opportunities in urban centers.

Dalit Vikas Abhiyan Samiti (DVAS) has been working for urban poor in Bihar. So that the quality of life of urban poor and informal sector workers has been enhanced by the active participation of community based coalitions in urban governance for securing their residential and livelihood rights through policy engagement at city, state and national level.



# **Enabling Inclusive Cities for the Homeless Communities**

First State Chapter Meeting – Bihar

A state level meeting has been organized by Dalit Vikas Abhiyan Samiti (DVAS) with the Support of OFFER and IGSSS for formation of a state level Network for understanding and ensuring the availability of benefit scheme and entitlement of homeless people in Bihar through the Network. Total 18 executive representatives of the 7 organizations had participated, including the OFFER team.

Experience sharing from baseline by CSO partners in Patna, Gaya, and Muzaffarpur and the personal learning, findings and challenges of the baseline done in 3 cities.

Data sharing of the 5 project districts in state Bihar on the baseline survey on homeless people and brief presentation on the SU LM and NULM.

## Scheme of shelters for urban homeless -

Deendayal Antyodaya Yojna National Urban Livelihood Mission by Priyanka Parmar (OFFER): -

- Ensure availability and access of the urban homeless population to permanent shelters including the basic infrastructure facilities like water supply, sanitation, safety and security.
- Cater to the needs of especially vulnerable segments of the urban homeless like the dependent children, aged, disabled, mentally ill and recovering gravely ill, by creating special sections within homeless shelters and provisioning special service linkages for them.
- Access to various entitlements, viz. social security pensions, PDS, ICDS, identity, financial inclusion, education, affordable housing etc. for homeless populations.
- Formulate structures and framework of engagement for development, management and monitoring of shelters and ensuring basic services to homeless persons, by state and civil society organizations including homeless collectives.

# Community Sensitization & Mobilization of Gram Sabha

During the community meeting, we have sensitized them about the participation in Gram Sabha, the stereotype practice of the society that, always the deprived and marginalized people were ignored in the society and they personally hesitate to participate in the meeting where some upper class have participated, they have always a fear to participate in parallel level with them, but after long sensitization process they have been participating in regular basis and they also raise the problem and argue with them about the problem and solution.

In the year 2019-20 with the support of our partner Organization we have successfully reached to more than 2600 peoples through Gram Sabha.



# Capacity Building of CBOs and Collectives on their scheme and entitlement

86 CBOs Meeting has been conducted in the year 2019-2020 in which 1,119 (331 Male, 528 Female and 260 Youth) people Participated.

The purpose of Meeting about the prohibition of the Government benefit schemes for rural poor and other scheme related to the livelihood, education, health, employment and Women empowerment.

The topic covered in the meeting are as following:


- How to avail the Government livelihood scheme. What are the procedure & eligibility, i.e. MNREGA

During the formation of the SSUS group, a total of 459 participants (162 Male and 297 Female) attended the meetings conducted during the reporting quarter. In the year 2019 - 2020, a total number of 22 Samavashi Siksha Unnayan Samiti have been formed at Village level.

With the support of our partners, we are able to raise the issues in front of government. Issues raised i.e. the problems faced by the Slums peoples on Urban Awash Yojana and issues will came in the planning of smart city, Admission of Poor children in private schools under RTE Act, discrimination with dalit children in schools, proper running of ICDs, adoption of new education methods, Work under MGNREGA etc.

During the meeting PRIs members, CBOs members, Youth club members and community members participated.

## **Gender Mainstreaming**

The gender mainstreaming programme has been organized by Dalit Vikas Abhiyan Samiti (DVAS). It has been undertaken mainly on gender policy and sharing, capacity enhancement on gender analysis, gender-sensitive planning and gender budgeting and periodic gender-specific review. 369 people have participated in the gender mainstreaming programme.

## Campaign on Women's Day

DVAS has organized a campaign cum "A walk is an outing made by walking" from 8th March 2019 to 14th March 2020 for made awareness on gender discrimination, safety & security of women and adolescent girls in the occasion of "International Women's Day". Women's Day Celebrated in the different project area of Dalit Vikas Abhiyan Samiti. Organized 24 meetings for incessant interaction with community leader and member for empowering them regarding the right and policies of government to make aware about the employment sustainability of their area to prevent the migration in another place for employment opportunities, also we have sensitized them for stereotype retention and practices.

### Formation & Training of Youth Groups

With the aim to inform the vulnerable adolescents about the vocational courses run by the government and encourage them to join the courses by improving their future prospect, livelihood opportunities and raising their family income. With this objective 40 youth groups have been formed in target villages. We have also adopted some strategy to reach more boys like involve boys in youth conclave at district and state level with active participation so that the participant boys would convey their valued experiences to the target group as a role model and encourage them to connect with the project activities.

#### Front line domestic worker and construction worker training

The objective of creating awareness to the domestic workers and construction works on their rights and entitlement about the workplace as well as in the society.

As "domestic work" is considered "women's work", an exceptionally large number of domestic workers are women. There is no common legal framework at the national level promoting and protecting the rights of the domestic workers though several legislations and notifications do exist to provide some coverage to domestic workers.

With the above subject **12** capacity building training was organized with domestic workers and construction workers on their rights and entitlements, in which altogether **216** participants participated.


## Formation of Slum Vikas Samiti at slum level


